




CONCUSSION TRAINING DAY

Brain Injury Australia presents a day-long training in best practice concussion assessment, treatment and management - featuring international and local leaders in the translation of the latest research into practice; Professor Barry Willer, Director of Research in the Concussion Management Clinic at the University at Buffalo in western New York and Professor Gary Browne, Director of the Sports Concussion Service at The Children's Hospital at Westmead, Sydney. Professors Willer and Browne will have just returned from the 5th International Consensus Conference on Concussion in Sport, to be held in Berlin at the end of October, and will present on any major changes to the consensus guidelines. They will be joined by physiotherapist Dr. Julia Treleven from the Whiplash and Neck Pain Research Unit at the University of Queensland.

BARRY WILLER is Professor of Psychology in the Department of Psychiatry at the University at Buffalo in western New York and is director of research at the University's Concussion Management Clinic - a world leader in research on the physiology of concussion. He has worked in the field of traumatic brain injury for over 30 years, written three books and around 140 peer-reviewed journal articles and book chapters. Professor Willer wrote the first return-to-play guidelines following concussion for both the International Ice Hockey Federation and the International Olympic Federation - the latter introduced at the Sydney Olympics in 2000. He leads a group of researchers who have conducted the first and only published evaluation of the return-to-play guidelines in the Consensus Statement of the last conference of the International Concussion in Sport Group, held in Zurich in 2012.



PROFESSOR GARY BROWNE is an Emergency Physician and Senior Physician in Sports and Exercise Medicine at the Children's Hospital Westmead, where he has been Director of the Sports Concussion Service since 2006. He is author and editor of over 100 peer-reviewed papers and 20 textbooks on paediatric emergency and sports and exercise medicine.



DR. JULIA TRELEAVEN is a Lecturer in the Division of Physiotherapy and a Senior Researcher in the Whiplash and Neck Pain Research Unit at the University of Queensland. She has published over 60 papers in peer-reviewed journals and is co-author of the book *Whiplash, Headache, and Neck Pain: Research-Based Directions for Physical Therapies* (2008). Julia works part-time as a physiotherapist in private practice assessing and treating patients with post-concussion syndrome, cervicogenic dizziness and whiplash.

THIS WORKSHOP has been designed for anyone with an interest in the assessment, treatment and management of concussion, including sports physicians, General Practitioners, physiotherapists, trainers, coaches and sports administrators. It will cover: the mechanics and pathophysiology of concussion; the on-field assessment and physical examination for concussion; developing a treatment plan for concussion; the use of neuropsychological testing; the assessment and differential diagnosis of post-concussive disorders; the treatment of comorbidities such as neck, oculomotor, or vestibular conditions; protocols for optimum return to play and "return to learn"; the special considerations given to concussed children and adolescents; and the current knowledge about the long-term consequences of concussion. The workshop will be both highly practical and highly interactive, with case examples used throughout to illustrate the learning objectives.


